1 INTRODUCTION

Royal University of Bhutan (RUB) is connected through Druk Research and Education Network (DrukREN) and has 9 constituent Colleges dispersed across the country mainly offering undergraduate programs with the Office of the Vice Chancellor as the central coordinating office.

As a member of DrukREN, University strives to make the best use of it through the services such as enhancing teaching learning, and research. All constituent colleges/institutions have their own Local Area Network with dedicated Internet lines of adequate access and bandwidth, capable of connecting to NREN. Additionally, RUB is in the process of establishing a digital library to provide ease of access to all NRENs that are connected to Bhutan.

Research is also gaining momentum with conducive policy and grant commitment but at this moment, it is highly restricted by the lack of availability of high-speed and stable network connection to global networks such as TEIN or other highways. It is further envisioned that with ICT support, research collaboration with international research centres and universities can be further enhanced through the R & E network.

RUB is seeking offers for the provision, delivery, installation, and support of Video Conferencing Devices and Accessories. We are inviting quotations for the proposed hardware equipment.

The maximum Budget allocated for the procurement of a MacBook is **3,900.00 Euros Taxes/VAT Included**The maximum Budget allocated for the procurement of Unifi Wi-Fi access points is **9,200.00 Euros Taxes/VAT**Included

2 BACKGROUND INFORMATION

2.1 Rationale behind this procurement tender

RUB and LEARNET have been awarded projects through 5rdCall for Proposals for Asi@Connect sub-granted projects in 2022 by TEIN*CC. From the procedure, a project titled "Connecting Bhutan and Lao through digital bridges to enhance Human Capital". The project tries to procure two MacBook to help, administer and manage the project and forty Unifi Wi-Fi access points for users attending the campus network and security training.

3 SOLUTIONS TO BE QUOTED

3.1 Technical Specifications

4 TIMELINE, DELIVERY, AND INSTALLATION

RUB plans to deliver the new proposed hardware and to be ready for operation by May **2023**. Prospective suppliers are required to quote a delivery lead time from receipt of the order.

4.2 Delivery and installation of new hardware

Prospective suppliers are required to quote for the delivery and installation service of the equipment.

The quoted prices shall include:

- Delivery to the site of installation on an agreed date set by RUB or by mutual understanding. All relevant taxes must be paid by the Bidder.
- o Turn-on and commissioning testing of the equipment and warranties.

5 COMMERCIAL ISSUES

RUB would plan to agree on contract terms with the successful supplier along the following lines.

5.1 Contractual

5.1.1 The Nationality and Origin Rule: Participation in tender procedures administered by TEIN*CC is open on equal terms to all natural and legal persons of the EU Member States and the States and territories of Asia Pacific region who are participating in the Asi@Connectproject (refer to the Annex 1). And it is also open to legal persons from non-EUOECD/DAC member countries namely Canada, Switzerland, and the United States. Tenderers are requested to provide the name(s) and country/countries of their legal entity/entities that could be used for contracting the Equipment with TEIN*CC (a Korean-based not-for-profit organization). Tenderers must state, in the quotation, the country of which they are nationals by presenting the usual proof of nationality under their national legislation.

Application of the Origin rule follows the same as that of the Nationality Rule aforementioned. Tenderers must state the origin of supplies and the Contractor must present proof of origin to RUB no later than when the invoice is presented. The certificate of origin must be made out by the competent authorities of the country of origin of the supplies and must comply with the rules laid down by the relevant Community legislation.

5.2 Pricing

- 5.2.1 Quotes must be itemized to list the price of all separate elements.
 - a) Pricing proposals shall each include:
 - Cost to RUB for each individual hardware component of the proposed solution expressed in terms of the basic cost elements Software (including details of licensing breakdown), if any
 - Cost of Delivery and Installation
 - Annual cost of the Support and Maintenance service, including any levels of service that are available

6 The SELECTION AND EVALUATION CRITERIA

The evaluation will be composed of three sequential steps, namely administrative compliance, technical compliance, and financial evaluation. If a tender cannot meet the administrative and technical compliance explained in 6.1 and 6.2, no further evaluation will be progressed. The award criterion applied to administratively and technically compliant tenders is price. Therefore, the successful tenderer is the one submitting the least expensive tender.

6.1 Examination of the administrative conformity of tenders

A tender is deemed to comply if it satisfies all the above conditions. If a tender does not comply with them, it will be rejected immediately and may not subsequently be made to comply by correcting it or withdrawing the departure or restriction.

6.2 Examination of Technical compliance of tenders

After analysing the tenders deemed to comply in administrative terms, the technical admissibility of each tender will be ruled on, classifying it as technically compliant or non-compliant, based on the specifications of 3.1 and 5.2.2 above.

6.3 Financial evaluation

The offer with the lowest price shall be awarded a contract. If the chosen tender exceeds the maximum budget available for the contract, the tender procedure will be cancelled, and TEIN*CC may negotiate with one or more tenderers of its choice, from among those that took part in the tender procedure, if they comply with the selection criteria, provided that the original procurement documents are not substantially altered and the principle of equal treatment is observed.

General Terms and Conations

- 1. The bid shall be evaluated on two categories and an award will be made based on the following categories:
 - (a) MacBook
 - (b) WiFi-Access Points
- The bidder(s) shall submit one original of the priced quotation with the Form of Bid and clearly marked ORIGINAL. In addition, a COPY of the bid is not necessary. The quotation including all documents in the attached format should be sealed in an envelope and addressed to and delivered to the following address.
- 3. Your quotation in the required format should be addressed and submitted to:

- 4. The bid shall be accompanied by a bid security of 2% of the total quoted amount in favour of the Registrar in the form of a cash warrant, demand draft, or unconditional Bank Guarantee valid 90 days from the last date of submission of bids. Any bid not accompanied by bid security shall be treated as non-responsive.
- 5. The supply of the goods shall be completed within *30* days from the date of issue of the Purchase Order, or the signing of the contract.
- 6. The supplier shall pay liquidated damages at the rate of 0.05% per day for each day of delay to a maximum of 10% of the quoted price.
- 7. The Purchaser is not bound to accept the lowest bid and reserves the right to accept or reject any or all the bids without assigning any reason whatsoever.
- 8. Normal commercial warranty/guarantee shall be 5 years for the goods so that if any faults are detected within the warranty period in the supplied/installed goods, the Supplier shall be bound to rectify the fault or replace the goods as the case may be. The security deposit shall be used to cover the cost of supplies not delivered or defective items not replaced or rectified. Full payment shall be paid after the completion of the project.
